The Leg Ulcer Forum

The Leg Ulcer Forum (LUF) provides a unique forum for nurses working within the field of leg ulcer management and wound care. The dedicated membership, i.e. healthcare professionals all working specifically with, or influencing the care of, patients with leg ulcers (whatever the aetiology), makes it one of the most influential patient-orientated organisations in the UK. Briefly, the aims of the LUF are to facilitate discussion, debate and reflective practice; disseminate new research, and identify and support areas of good practice; provide support to specialist nurses involved in both identifying the need for and establishing leg ulcer services; and encouraging continuous professional development through a variety of educational activities. Membership is open to professionals involved in the prevention and treatment of leg ulceration and costs only £15 per year, for which members receive at least eight dedicated mailings — including personal copies of the *Leg Ulcer Forum Journal*, exclusive educational publications, The Wound Care Supplement from the *Nursing Times* (produced in collaboration with the LUF) — and access to the Forum's website. Two of the keystones of the TVNA have been peer support by providing a forum for nurse specialists to share views, ideas and experience, and our political voice. Two new guidelines have been developed and are now accessible to members via our website. The sharp debridement guidelines and competency statements have been developed to assist clinicians in this area of clinical practice. Many pieces of research and guides to good practice have highlighted the need for debridement as a method of managing necrotic burden. However, clinicians can find themselves having to expand their scope of practice to facilitate this. Nurses and employers need to be assured that clinical skills are developed to safely match this need. The management of cellulitis guidelines provide a framework to enable clinicians to develop local protocols for the management of this all-to-common condition. In the political arena, Dai Havard MP hosted a reception at the Houses of Parliament on behalf of the association in October. The aim of this meeting was to highlight the development of wound care and the key role that tissue viability nurses have had in making the UK the centre of excellence in wound care. However, the meeting was also used to highlight to MPs and the Government that there are significant areas of improvement yet to be made. www.tvna.org
